The Department of Pre-trial Services is requesting the County Board to approve executing a contract with the Wisconsin Policy Forum for a Racial Equity Coordinator (\$124,466 Year 1; \$35,148 Year 2) and Administrative Assistant (\$10,000 Year 1; \$10,000 Year 2) for the Milwaukee Community Justice Council under the John D. and Catherine T. MacArthur Foundation’s Safety and Justice Challenge Grant. The budget is a total of \$179,614 from January 1, 2021 to December 31, 2022. There is no fiscal impact in regards to executing the contract.
