- A. The Department of Health and Human Services (DHHS) is requesting to create 1.0 FTE Housing Program Assistant position. This would increase expenditures that would be offsett by an increase in operating revenues.
- B. DHHS will receive additional federal Housing and Urban Development (HUD) funding through increased administrative fees that will support 100 percent of the cost of the Housing Program Assistant position.

The new 1.0 FTE Housing Program Assistant position would be at pay grade 16Z3, with a current pay range of \$39,706 - \$47,420 for salary (\$42,684 - \$50,977 with salary and social security). The DHHS assumes filling the position in Pay Period 8. The direct cost impact (salary and social security plus 1% mid-year raise) for 2021 is \$31,449 - \$37,560 in expenditures for 1.0 FTE Transportation Coordinator position, offset by \$31,449 - \$37,560 in federal revenues.

- C. There is no direct cost impact in 2021 to create 1.0 FTE Housing Program Assistant position as the increased operating expenditures are covered by increased federal revenues.
- D. Assumptions include: Filling the 1.0 FTE at step 1 in pay period 8.
