Subject: Authorization to Amend Existing Golf Cart Lease - ACTION

Issue

Milwaukee County Parks requests authority to amend the existing golf cart lease with Yamaha Motor Finance to increase golf cart quantities by forty-six golf carts at a total cost of \$86,940, or 28,890 per year of the remaining three years of the lease.

Background

Milwaukee County Parks boasts a world class municipal golf course system. Due to a surge in popularity resulting in increased usage, more golf carts are needed. Milwaukee County Parks proposes adding an additional forty-six carts at nine different courses. The annual additional lease expense is \$28,890. Conservative revenue estimates are anticipated at \$115,000. Additional revenue from added carts will be utilized for seasonal labor to offset labor reimbursed by CARES funding in 2020, gasoline and maintenance of the vehicles.

Recommendation

Parks' Executive Director recommends approval to amend the existing golf cart lease with Yamaha Motor Finance and authorization to execute the necessary documents.
