MILWAUKEE COUNTY CARES ACT GRANTS FOR ARTS AND CULTURE

TECHNICAL BRIEF

This document is intended to provide further detail on the allocation of \$700,000 in CARES Act relief money for Milwaukee County arts and culture organizations in December 2020.

ALLOCATION FRAMEWORK, SCORING, AND ELIGIBILITY

Applicants were asked to report their total COVID-related losses and COVID-related relief to date. With a cap of \$125,000, the difference between those two amounts was the maximum grant amount for which the applicant organization was eligible. Any organization that reported more COVID-19 relief than losses was ineligible.

As the chart shows below, the total amount of remaining need and the total amount of eligible grant asks for this opportunity greatly exceeded the grant funds available:

To ensure that all eligible organizations could receive a share of this grant, the County determined that all eligible organizations would be approved at 13.4% of their eligible grant amount.

Approved organizations were then scored through the County's racial equity scoring framework, which is based on the zip codes in which the organization is headquartered and the zip codes the organization serves. Based on this framework, a perfect score is 10. Approved organizations that scored a 7 or above received a priority premium on their award.

- Organizations that scored a 7 received an additional \$1,000
- Organizations that scored an 8 received an additional \$2,350
- Organizations that scored a 9 received an additional \$5,000
- Organizations that scored a 10 received an additional \$10,000

Of the 82 organizations that applied for this grant, six organizations were found to be ineligible. The reasons why an organization was deemed ineligible were:

- Inability to provide the required documents to be eligible
- Not being a 501c3 organization or not applying under the 501c3 arm of another entity
- Not having fully articulated how the presentation, production, or exhibition of arts and cultural programming or education is a core component of the organization's mission or goals
- Having reported that COVID-19 Relief Funds received exceed COVID-19 losses
