- A. The Director of the Office of Emergency Management (OEM) is requesting adoption of a resolution which will abolish one FTE Administrative Assistant and create one FTE Executive Assistant. The OEM Director has determined that a higher level of administrative support is needed to provide assistance and oversight to the four divisions of OEM.
- B. The Administrative Assistant position that is set to be abolished was budgeted in pay grade 06P at a salary of \$38,350 for 2021. The new Executive Assistant position has been priced in the 25M paygrade which starts at \$53,485 annually. Assuming the position is hired at the midpoint of pay range 25M and is able to start in Pay Period 7, this would be a 2021 cost increase for salary and Social Security of \$3,898. This additional cost in 2021 is anticipated to be covered by savings related to another position hired below the budgeted salary.
- C. There will be no tax levy impact in 2021 related to this abolish/create. The additional cost of creating the Executive Assistant position will be funded by savings related to another position hired below the budgeted amount. In 2022, OEM plans to fund the Executive Assistant position while remaining within the tax levy target.
- D. This fiscal note assumes the Executive Assistant position will be hired at the midpoint of the 25M pay range with a pay period 7 start.
