- A. The Department of Transportation is requesting to abolish 1.0 FTE vacant Highway Maintenance Worker 3 position, and create 1.0 FTE Assistant Supervisor position in the Highway division of the Department of Transportation (DOT).
- B. There is a net cost to the Highway division of roughly \$1,059 when abolishing \$56,632 with the vacant Highway Maintenance Worker 3, and creating the Assistant Supervisor (\$63,690). This net cost (\$1,059) is absorbed in the division 2021 budget. There is a March 2021 fund transfer moving money within the division in order to ensure proper salaries will be available.
- C.The direct cost to the County for the action is roughly \$1,059. This is absorbed within the division budget as well as a fund transser moving money to cover the difference. The Highway division will need to cover the increase in subsequent years.
- D. Assumptions include: abolished at mid range, hired at midrange, 85% of the overall cost of \$7,058 is covered by the state. A March County fund transfer moves money within the division to cover the difference.
