Re: Extension for Temporary Assignment to a Higher Classification (TAHC)

Policy

Chapter 17.085 of the Milwaukee County Code of General Ordinances requires an extension of temporary assignment beyond 180 days be approved by the Milwaukee County Board of Supervisors.

Request

The Office of the Sheriff is requesting a retroactive extension of Charles Stowers' Temporary Assignment to a Higher Classification (TAHC) to the Sheriff's Office Captain position from 3/27/2021 to 6/27/2021, or until the position is filled permanently, whichever comes first. Approval of back pay for this employee is also kindly requested, as the current TAHC expired on March 27, 2021.

The request is being made to maintain consistent leadership until the position is filled on a permanent basis. The Sheriff's Office is currently in the interview stage of the recruitment process.

CONSUMER DISCLOSURE

From time to time, Wisconsin Milwaukee County (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
