Wisconsin Legislation followed by the Wisconsin Aging Action Network:

- [AB201](#) absentee ballot applications, unsolicited mailing or transmission of absentee ballot applications and absentee ballots, canvassing absentee ballots, electronic voter registration, and providing a penalty.
- SB 203 / AB 192 (LRB 1537) – The secure delivery of absentee ballots and providing a penalty: Would limit options to obtain and return absentee ballots. This bill would limit who can return the voter’s absentee ballot to the voter’s immediate family or legal guardian, with some very limited exceptions.
- [SB 204](#) (LRB 2032) - Absentee ballot applications, unsolicited mailing or transmission of absentee ballot applications and absentee ballots, canvassing absentee ballots, electronic voter registration, and providing a penalty: This bill requires indefinitely confined voters to provide a photo ID with their absentee ballot request. The bill eliminates the option for indefinitely confined voters to receive an absentee ballot automatically for any election. Clerks, the Election Commission, and other groups would no longer be allowed to mail absentee ballot applications to all eligible voters; this bill makes it a felony to mail absentee ballot applications to anyone who has not requested one.
- [SB 205](#) / AB 179 (LRB 1935) - Absentee voting in certain residential care facilities and retirement homes and providing a penalty: Would limit voting rights of nursing home and group home residents. If staff offered to provide a resident with assistance, this would be a felony. This bill would require the administrator of the facility to notify relatives of the residents as to when the special voting deputies will be coming to the facility to assist in the casting of absentee ballots.
- [SB 206](#) / AB 180 (LRB 0428) - Status as an indefinitely confined voter for purposes of receiving absentee ballots automatically and providing a penalty: Would limit voting rights of voters who certify as “indefinitely confined”. These voters would be required to provide statements under oath. Voters under 65 would need to have their statements signed by their doctors. A false statement would be a felony. Voters would need to renew their status every two years. Currently, these voters receive an absentee ballot for every election for as long as they need it.
- [SB 209](#) / AB 177 (LRB 1585) - Returning Absentee Ballots/Ballot Drop Boxes: Requires voters to either mail or drop off their absentee ballots at the permanent location of the clerk's office. It allows a municipal clerk to authorize the use of a drop box but limits it to a location that is attached to the municipal clerk's permanent office. It also sets out standards for the drop boxes, including that they be tamper resistant, moisture-proof, satisfy the accessibility requirements under the federal Americans with Disabilities Act, and be emptied once each day at 9

a.m. by the clerk or deputy clerk in public view.

- [SB 212](#) (LRB 2033) - Defects on Absentee Ballot Certificates: Prohibits a municipal clerk from correcting a defect on the completed absentee ballot certificate envelope. If a certificate envelope has a defect, the clerk must post a notification of the defect on the elector's voter information page on the MyVote website. This bill also adds to the list of what is considered election fraud from election officials to include intentionally assisting or causing the casting or counting of a vote or the receipt of a registration that is invalid as well as several other factors.
- [SB 213](#) – Expanding DAs prosecuting power over elections
- [SB 214](#) (LRB-2284) - Early canvassing of absentee ballots, issuance of presidential ballots, combined polling places, timeline for sending or transmitting absentee ballots: This bill allows municipal clerks to start canvassing the absentee ballots the day before the election. This bill authorizes any city, village, or town with a population of less than 35,000 to enter into an agreement to share a polling place with an adjacent city, village, or town also having a population of less than 35,000. Transportation is already a significant barrier for many voters, combining polling sites would only serve to magnify this challenge.
- [SB230](#) This bill allows a nursing home or assisted living facility resident and a patient in a hospital, or his or her guardian or health care agent, to designate an essential visitor to visit and provide support for the resident or patient. The bill requires a nursing home, assisted living facility, or hospital to also allow a member of the clergy to visit a resident or patient.
- [SB17](#) Increased penalties for crimes against elder persons; restraining orders for elder persons; freezing assets of a defendant charged with financial exploitation of an elder person; sexual assault of an elder person; physical abuse of an elder person; and providing a penalty.
- [SB18](#) Expediting criminal proceedings when a victim or witness is an elder person and preserving the testimony of a crime victim or witness who is an elder person.
- [SB19](#) Financial exploitation of vulnerable adults.
- [SB20](#) Financial exploitation of vulnerable adults with securities accounts, violations of the Wisconsin Uniform Securities Law, granting rule-making authority, and providing a penalty.
- [Wisconsin Act 9](#) Pharmacy benefit managers, prescription drug benefits, and granting rule-making authority (Signed into Law).
- [Assembly Bill 786](#)/[Senate Bill 734](#) establishes mandatory initial training requirements for guardians before they are appointed. (This bill has passed the Assembly and is awaiting action in the Senate.)
- Other proposals to watch – election law changes to be proposed soon.

## Utility Shut-off Moratorium in Wisconsin will End on April 15th.

Wisconsin's annual moratorium on cold weather disconnections, for utility service used for home heating is in effect until April 15, 2021. Water, electric, and gas utilities seeking to request the ability to disconnect during the winter moratorium will have to file a disconnection plan with the PSC and receive approval before they can proceed with disconnections. Your bill is still due.

If you need help with utility disconnections during the COVID-19 outbreak, call the PSC Consumer Affairs team at: 1-800-225-7729. Due to the COVID-19 Public Health Emergency, in-person applications are not being conducted.

## ACA Marketplace Special Enrollment Period Extended to August 15, 2021

The Affordable Care Act (ACA) health insurance marketplace special enrollment period has been extended to August 15, 2021. Consumers now have until August 15 to sign up for a health insurance plan through the marketplace. Consumers who are eligible and enroll under the SEP will be able to select a plan with coverage that could start as soon as the first month after plan selection, and current enrollees will be able to change to any plan available to them in their area. On December 1, nine organizations in Milwaukee County launched the Milwaukee Rental Housing Resource Center, a one-stop shop for tenants and landlords in need of assistance to maintain or provide stable rental housing. The mission of the Milwaukee Rental Housing Resource Center (MKE RHRC) is to serve as a trusted convener for the rental housing system and to connect people to resources, education, and services that help prevent eviction, regardless of age, family situation, or housing status.

## National Federal Eviction Moratorium

Learn About Protections and Steps Renters Must Take!

A federal eviction moratorium issued by the Centers for Disease Control (CDC) is in effect until June 30, 2021. A "covered person" is any tenant, lessee, or resident of a residential property who provides to their landlord, the owner of the residential property, or other person with a legal right to pursue eviction, a declaration under penalty of perjury that: (1) The individual has used best efforts to obtain all available government assistance for



rent or housing;

(2) The individual either (i) expects to earn no more than \$99,000 in annual income for Calendar Year 2020 (or no more than \$198,000 if filing a joint tax return), (ii) was not required to report any income in 2019 to the U.S. Internal Revenue Service, or (iii) received an Economic Impact Payment (stimulus check) pursuant to Section 2201 of the CARES Act;

(3) The individual is unable to pay the full rent or make a full housing payment due to substantial loss of household income, loss of compensable hours of work or wages, a lay-off, or extraordinary out-of-pocket medical expenses;

(4) The individual is using best efforts to make timely partial payments that are as close to the full payment as the individual's circumstances may permit, taking into account other nondiscretionary expenses; and

(5) Eviction would likely render the individual homeless— or force the individual to move into and live in close quarters in a new congregate or shared living setting—because the individual has no other available housing options.

A tenant, lessee, or resident of a residential property must provide a completed and signed copy of the declaration, as described above, to their landlord, owner of the residential property where they live, or

other person who has a right to have them evicted or removed from where they live.

The declaration may be signed and transmitted either electronically or by hard copy.

Each adult listed on the lease, rental agreement, or housing contract should complete the declaration. In certain circumstances, it may be appropriate for one member of the residence to provide an executed declaration on behalf of other adult residents party to the lease, rental agreement, or housing contract at issue. ### Mortgage Payment Assistance

The Federal Housing Administration (FHA) announced the third extension of its foreclosure and eviction moratorium through June 30, 2021, for homeowners with FHA-insured single family mortgages covered under the Coronavirus Relief and Economic Security (CARES) Act. The moratorium continues to direct mortgage servicers to:

- Halt all new foreclosure actions and suspend all foreclosure actions currently in process for FHA-insured single family properties, excluding legally vacant or abandoned properties; and
- Cease all evictions of persons from FHA-insured single family properties, excluding actions to evict occupants of legally vacant or abandoned properties.
- Homeowners with FHA-insured mortgages should continue to make their mortgage payments during the foreclosure and eviction moratorium if they are able to do so, or seek mortgage payment forbearance pursuant to the CARES Act from their mortgage servicer, if needed.

Pursuant to the CARES Act, FHA requires mortgage servicers to:

- Offer borrowers with FHA-insured mortgages delayed mortgage payment forbearance when the borrower requests it, with the option to extend the forbearance for up to a year. FHA does not require a lump sum payment at the end of the forbearance period.
- Assess borrowers who receive COVID-19 forbearance for its special COVID-19 National Emergency Standalone Partial Claim before the end of the

forbearance period. The COVID-19 National Emergency Standalone Partial Claim puts all deferred mortgage payment amounts owed into a junior lien which is only repaid when the borrower sells the home, refinances the mortgage, or the mortgage is otherwise extinguished.

- Assess borrowers who are not eligible for the COVID-19 National Emergency Standalone Partial Claim for one of FHA's COVID-19 expanded home retention solutions announced on July 8, 2020.

Area banks, credit unions and mortgage holding companies are offering a variety of customer assistance programs that will allow borrowers to suspend mortgage payments for up to 180 days without facing fees, penalties or hits to their credit score in response to the Covid-19 pandemic. Residents must contact your servicer to request a payment plan.
