I. CALL TO ORDER

II. REVIEW AND APPROVAL OF THE NUTRITION COUNCIL MEETING MINUTES FROM OCTOBER 27, 2020

III. MCDA PROGRAM AND POLICY COORDINATOR: DAN IDZIKOWSKI

- a. Advocacy Updates: Mr. Idzikowski provided a few advocacy updates.
 - Dan informed the Nutrition Council that the Division on Aging must develop their 2022-2024 Area Plan; this is a requirement by the State. The plan consists of Demographic analysis, needs analysis, and plan goals. The State provides a template for the aging units to follow to ensure all areas meet the needs of seniors in the County.
 - Congress passed a new federal COVID-19 relief package: Coronavirus Response and Relief Supplemental Appropriations, or CRRSA, Act.
 - The integration plan with DHSS was effective as of January 1, 2021 and we are now the Milwaukee County DHHS Division on Aging.

IV. MCDA COMMUNITY PROGRAM COORDINATOR: BEKKI SCHMITT

- a. Wellness and Intergenerational Program Update
 Bekki shared with the group they are recruiting facilitators for *Stepping On Fall Prevention* wellness workshop. Participants will receive training and support to provide strategies for adults to help them live healthier lives.
 Trainings available Spring 2021. For more information call 414-289-6352.
- Division on Aging is partnering with Starms Early Childhood School and Serving Older Adults to foster intergenerational relationships. The goal is to engage both young and old, bridge the gap between generations and enable elders to share their wisdom and experience to nurture the young.
 During COVID these will be virtual activities.

V. MCDA SENIOR DINING PROGRAM COORDINATOR: GAYLYN RESKE a. Online Reservation System Pilot

The online dining reservation pilot was made possible through a COVID Relief fund emergency response grant related to technology and access for older adults during the pandemic. The process is complete, and we will be starting a small pilot with the Kelly Senior Center within the next month.

b. Menu and Site Updates

Gaylyn discussed the need to continue cold meals during the time in which we will continue curbside pick-up from the dining sites. We are partnering with a few minority restaurants and they will be offering gluten free lunch. In response to a question about gluten free meals option. Gaylyn suggested that the new Restaurant Model might be able to accommodate special dietary requests like Gluten Free and Vegetarian that our current Catering model has not been able to address.

c. Introduction of Nutrition Council Chair and Co-Chair nominees and election process

2021 Elections-We have four nominees for the upcoming election. Sally Lindner, Barbara Bechtel, Mary Killins, and Emma Williams are on the ballot. The election process is online. The ballot has been created as a Google Doc. It is confidential. You will only be allowed one vote. **You have until 4:00pm on Tuesday, February 16th to submit your vote.**

VI. MCDA NUTRITION OUTREACH COORDINATOR: LORIE O'CONNOR

a. Announcement of Site Representatives

Lorie had shared with the group that each site was provided a form to report their Nutrition Council elections results. According to the bylaws, each site must have minimally one representative, a diner/volunteer that frequents a dining site minimally one time per week. Representatives are the voice and ears for our Nutrition program, advocating for other seniors.

b. Recipe contest announcement/updates

We are having a recipe contest. If you have a favorite side dish, salad or dessert that get raves reviews. This is the opportunity to share and submit your favorite recipe.
