Subject: Wilson Park Development & Maintenance agreement between Milwaukee County Parks and the South 27th

Street Business District Association (ACTION)

Issue

Milwaukee County Parks is submitting for approval a development and maintenance agreement between Milwaukee County Parks and the South 27th Street Business District Association (Historic Highway 41).

Background

Milwaukee County adopted File #21-119 requested Milwaukee County Parks enter into an agreement with the South 27th Street Business District for construction and maintenance of a new garden at Wilson Park. Staff from Milwaukee County Parks and the South 27th Street Business District Association negotiated an agreement for an area in the northwest corner of Wilson Park bounded by Van Beck and Howard Avenue (Exhibit A) for an initial term of three years with three additional three-year term renewals by mutual agreement. The South 27th Street Business District Association will construct and maintain a garden with pathways, flower beds and art installations that honor the history of Highway 41 on approximately 2.3 acres. A Phase 1 Environmental Site Assessment has been completed by the association and reviewed by DAS-Architecture and Engineering Environmental Services Division and revealed no recognized environmental conditions.

The proposed agreement requires the South 27th Street Business District Association to make \$30,000 worth of improvements to the project site and fully maintain such improvements for the term of the agreement. Park standards shall be incorporated into the project and plan review by Park staff will occur prior to construction. The agreement differs from recent agreements with third party partners wherein there is no funding set aside for either maintenance of the area or funding to restore it to previous condition. In lieu of that contract component, the 27th Street BDA has agreed to provide annual financial reporting. The contract does require that the site be restored to original condition upon termination of the agreement by the South 27th Street Business District Association.





Recommendation

Parks' Executive Director requests approval of a development and maintenance agreement between Milwaukee County Parks and the South 27th Street Business District Association.
