

Overall Sentiment







Overall Sentiment





Questions: Who paid for the Public Opinion Strategies poll? What were the questions? Can we get more detail on methodology? The firm generally works for Republicans and has been accused in the past of push polling, or phrasing questions to get a desired answer.

WisDOT, in its presentation, said some groups opposing the expansion project are "anti-highway." What is the agency's criteria for so labeling a group? (Every person I've talked to acknowledges the need for reconstruction, but not expansion.)

I have been to two meeting held by WisDOT. Support for sound walls was NOT expressed at either. There may be support if the choice is never sleeping because of the noise from a wider freeway and all the frontage roads or a sound walls, but generally people have opposed expansion.

The footprint is important, but so is the height of the socks. The Interchange would be 25 feet taller than the existing one and would send more pollution floating into surrounding neighborhoods. (In Story Hill, the freeway is BELOW the height of the bluff. WisDOT's plan would elevate the Interchange above the bluff.)

3,3333 jobs per mile? Really? Are they all construction jobs? How many FTEs? What is the basis of that figure? How is it calculated?

WisDOT, at meetings I have attended, is the one that says taking traffic off local roads is a good thing. It certainly doesn't help businesses that rely on that traffic to survive.

This resolution was adopted by a 16-1 vote at the last Board meeting. Since then Lt. Gov. Mandela Barnes has issued a public statement in opposition to the expansion of I-94 and WisDOT, in consultation with the Federal Highway Administration has agreed to revisit their EIS to include current conditions. This will open up the discussion and public input County Executive Crowley has expressed concern about.
