Issue

Parks requests authorization to grant a permanent infrastructure easement to the Milwaukee Metropolitan Sewerage District (MMSD) by the Oak Leaf Trail and Edgewood Avenue in the Village of Shorewood.

Background

MMSD is making improvements to its sewer system in the Village of Shorewood along Edgewood Avenue. A part of the improvements cross into parkland by the Oak Leaf Trail and Edgewood Avenue in the Village of Shorewood.

Parks has reviewed MMSD's plans for the infrastructure easement and finds them consistent with its present and future plans for this area of parkland, near the Oak Leaf Trail, with minimal impacts to surrounding areas. This easement will be permanent and will be for approximately 0.02 acres. Due to the diminutive size of the easement area, the minimal impact to parkland, and the benefit to the community Parks staff recommends approval of this easement. The fee for this easement has been set at \$100.00.

Recommendation

Parks' Executive Director recommends authorizing Parks to prepare, review, approve, execute, record and/or implement the required documents or preform actions required to grant a permanent infrastructure easement to the Milwaukee Metropolitan Sewerage District (MMSD) by the Oak Leaf Trail and Edgewood Avenue in the Village of Shorewood. It is further recommended that the County Executive and County Clerk be authorized to execute any required documents to carry out this action.
