A. This is a request to increase the County's contract with Employ Milwaukee by an additional \$300,000, from previously-approved \$3.5 million, to a total of \$3.8 million. The contract would cover the same services (administration of an employment program, training and employing Milwaukee County residents in jobs focused on mitigating COVID-19). The \$300,000 in additional funds would come from previously approved funds in File 20-937, which provided \$5.0 million in funding from debt service reserve for COVID-19 related needs.
