 - A. Milwaukee County Parks is requesting to create 1.0 FTE Assistant Director of Operations position to provide oversight, coordinate and manage support of park operations; oversees facility management, park operations, golf & turf operations, parkways, forestry, natural areas, trails management, playground maintenance, landscape construction, and fleet management; directs manager activities within countywide vision, departent goals and project objectives; all duties performed in conjunction with Division Director.
 - B. Milwaukee County Parks has designated this position to be funded in 2021 by abolishing the Parks Officer Development position, which has been vacant throughout 2021 and using funds from Parks Officer Development position to fund the Assistant Director of Operations position. Assuming this position is hired in August 2021 or near pay period 18 the remaining salary of 2021 will be around \$27,400 and a total salary of \$82,204 in subsequent years.
 - C. Current year and subsequent year costs- no additional costs for remainder of 2021 Funding source if costs increase due to this action – tax levy/revenue in 2022 budget

D. This fiscal note assumes the Assistant Director of Operations position will be hired for 1.0 FTE at pay grade 916E and hired near pay grade 18 or August 21st, 2021.
