From the Executive Director of Milwaukee County Parks requesting authorization to abolish one (1.0) FTE Officer Development and create one (1.0) FTE Assistant Director of Operations, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Department of Parks, Recreation, and Culture (DPRC) is requesting to create one Full-Time Equivalent Assistant Director of Operations position and perform all duties in conjunction with the Division Director, DPRC; and

WHEREAS, in addition to providing oversight, coordination, and management support; this position is intended to focus on developing and implementing goals as well as support in the hiring full-time and seasonal operations staff; and

WHEREAS, this oversight provides operational direction to ensure proper maintenance and stewardship of the physical park system including parkways, buildings, amenities, playgrounds, trails, waterways, forests, wetlands, beaches, ravines, savannahs, and other recreational amenities; and

WHEREAS, the Assistant Director of Operations will also coordinate vehicle and equipment priorities with the Fleet Management Division, Department of Transportation; and

WHEREAS, this additional assistance will also provide increased capacity for strategic direction and initiatives by the Director of Operations and Skilled Trades; and

WHEREAS, the Assistant Director of Operations will aid the Director of Operations and Skilled Trades in coordinating daily activities within DPRC, and expand the capacity for the north, central, south, and forestry Operations Managers; and

WHEREAS, there will be no tax levy impact for this position; and

WHEREAS, the Committee on Finance, at its meeting of July 26, 2021, recommended adoption of File No. 21-616 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and approves the abolishment of one Full-Time Equivalent (FTE) Parks Office Development Position and the creation of one (FTE) Assistant Director of Operations position to be filled beginning near August 21, 2021, or Pay Period 18:
