Subject: Authorization of the continued extension of Patrick Brost's TAHC to the position of Airport Public Safety and Security Assistant Manager from July 1, 2021 through September 6, 2021.

REQUEST

The Department of Transportation is requesting an extension of Patrick Brost's Temporary Assignment to a Higher Classification (TAHC) to the position of Airport Public Safety and Security Assistant Manager through September 6, 2021. The request is being made to maintain consistent leadership prior to the permanent filling of the Airport Public Safety and Security Manager position. The current Airport Public Safety and Security Assistant Manager is temporarily filling the role of Manager until September 6, 2021. A candidate for Director has been selected and the start date for that individual is September 7, 2021.

POLICY

Chapter 17.085 of the Milwaukee County Code of General Ordinances requires an extension of temporary assignment beyond 180 days be approved by the Milwaukee County Board of Supervisors.

The current Airport Public Safety and Security Assistant Manager is temporarily filling the role of Manager until September 6, 2021.
