  - A. The Zoological Department requests retroactive authority to apply, and accept, for the 2021 Shuttered Venues Operator Grant (SVOG) from the U.S. Small Business Administration.
  - B. Approval of this request will result in 2021 SVOG funds totaling \$6,849,482.40 awarded to the Zoo for revenue loss as a direct result of the COVID-19 pandemic.
  - C. The SVOG does not require a local match. The funds, which are forwarded to the County and pursuant to grant guidelines, must be held in a separate non-interest-bearing trust account.

In order to shore up revenue loss sustained by the Zoo as a direct result from the COVID-19 pandemic, it is recommended that the Comptroller's Office in conjunction with the DAS-PSB and Zoo are directed to establish a new trust fund and have administrative authority to recognize the revenue and align expenditure authority per the grant rules to benefit the Milwaukee County Zoo.

D. This grant does not require a local match. Grant consistent with the department's role and mission, not requiring a County match, not contrary to adopted budget or policy, and not requiring the County to commit appropriations from a budget year that has not yet been adopted. Zoo's request will include administrative approval to transfer funds to a separate trust fund.
