- A. Adoption of this resolution will grant two permanent easements to the City of Wauwatosa for previously County-owned water mains and related utilities on County Grounds and in Menomonee River Parkway.
- B. No costs, savings, or anticipated revenues because operation and maintenance of the water system was transferred by formal agreement to the Milwaukee Regional Medical Center in October 2019 (see County Board File 20-236). Existing staff time will be utilized to complete the easements.
