BACKGROUND

Milwaukee County Zoo (MCZ), Zoological Society of Milwaukee County (ZSM), International Crane Foundation (ICF), and University of Wisconsin School of Veterinary Medicine (UWSVM) have partnered to maintain a rotating Veterinary Residency program since the year 2000. The program provides board certified veterinary graduates with a diverse range of hands-on experience in exotic, domestic, and wild animal medicine while simultaneously enhancing the capacity of veterinary care for the MCZ. Each resident remains in the program for three consecutive years, overlapping with the residents of the previous cycles and rotating between the MCZ, ICF, and UWSVM seasonally. The program has been tremendously successful, and many of the Veterinary Residents have graduated the program and been recruited by prominent zoological facilities, including our own MCZ.

ALIGNMENT TO STRATEGIC PLAN

1B: Create and nurture an inclusive culture across County government through partnerships with local university and mission parallel organizations to provide work experience to veterinary graduates.

3B: Enhance the County's fiscal health and sustainability by increasing capacity for the veterinary care at Milwaukee Cunty Zoo at approximately one third the cost of hiring an additional full-time veterinarian. Maximize the health and wellness of the Zoo's animal residents and ensuring a wholesome recreational environment for the citizens of Milwaukee County.

FISCAL EFFECT

The 2021 Adopted Budget includes funding for this contract. The contract does not increase capital expenditures or use contingency funds or grant funds. The contract does commit funds across three successive budget cycles. The contract does provide one full-time equivalent of licensed veterinary services at approximately one third the cost of hiring an additional full-time veterinarian.

TERMS

The 2021 Adopted Budget includes funding for this contract. The term of the 2021 Veterinary Residency program would extend from July 1, 2021 until June 30, 2024.
