A. The Department of Health and Human Services (DHHS) is requesting to create 1.0 FTE Community Intervention Specialist position to be located at the House of Corrections (HOC).

B. The new 1.0 FTE Community Intervention Specialist position would be at pay grade 24, with a pay range of \$52,843 - \$61,209 for salary (\$56,843 - \$66,221 with salary and social security. DHHS assumes filling the position in Pay Period 21. The direct cost impact for 2021 is \$13,183 in expenditures (including salary and social security) for 1.0 FTE Community Intervention Specialist position (if filled at step 1).

C. There is no direct cost impact in 2021 to create 1.0 FTE Community Intervention Specialist position at Step 1 as the position is being paid for by an Interdepartmental Fund Transfer from the HOC maintenance budget (account 60600) that is not going to be fully expended in 2021. HOC has budgeted a crosscharge with the DHHS for this in its 2022 budget.

D. Assumptions include: Filling the 1.0 FTE at step 1 in pay period 21.
