 - A. The retirement of the former Group Sales Coordinator has provided the opportunity to update the responsibilities of the position, giving it a greater sales focus.
 - B. This will be a new annual fiscal absorption in the 2021 budget and this action is included in the Zoo's 2022 request. Planned to and if hired by November 1st, 2021 the remaining year will be \$11,133. With annual salary of \$69,514. This position is to increase number of County contracts awarded to minority and women-owned businesses, apply racial equity lens when considering a diverse applicant pool and enhance Milwaukee County's fiscal health by increasing group sales revenues. Thus making the Zoo less dependent on a tax levy.
 - C. The budget impact will be absorbed in the 2021 budget and this action is included in the Zoo's 2022 request. Planned to and if hired by November 1st, 2021 the remaining year will be \$11,133. With annual salary of \$69,514. With the elimination of the Group Sales Coordinator salaried at \$65,514, the remaining difference and increase in Operating personnel will be \$4,018 per year.
 - D. This position of Group Sales Manager is expected to be hired at the salary point of \$69,514, pay range code 30M and a starting date of November 1st 2021.
