- A. Approval of this resolution will signal approval of a proposed Milwaukee County Supervisory map as determined by the Milwaukee County Board of Supervisors to be used for elections beginning in 2022.
 - B. There are no costs with adopting the recommended maps as proposed in this resolution. An expenditure of staff time will be required to transmit the maps and ready the materials for elections beginning in 2022. The Milwaukee County Board appropriated \$80,000 on March 25, 2021, to cover the expenses related to the creation and operation of the Independent Redistricting Committee (File No. 21-304). For the purposes of this resolution, the services of the Southeastern Wisconsin Regional Planning Commission (SEWRPC) to assist the County Board in developing a map will be paid from the appropriations made earlier this year.
 - C. There are no budgetary impacts in 2021 or 2022 if this file is adopted.
 - D. No assumptions were made.
