Supervisor Staskunas requested that Intergovernmental Relations staff pose questions through a friendly legislator, legislative counsel, the Legislative Reference Bureau (LRB), and/or the drafter as to who the employees of the Behavioral Health Division will be working for and provide this information in writing. The LRB should also be queried as to whether this model of running a behavioral health system was based on another county in Wisconsin and how other counties in Wisconsin run their mental health systems.

Supervisor Haas requested that Corporation Counsel and the Comptroller provide an informal written opinion specifically on the tax levy limit, the Mental Health Board's ability to impose taxation, and its impact on other County departments.

Supervisor Alexander requested information as to how to determine, by reading through the County ordinances, which ordinances will apply and which ordinances will not apply to the Mental Health Board and how that will affect mental health going forward.

Supervisor Staskunas requested that Intergovernmental Relations staff draft a letter that reflects all questions asked by the Committee to the drafter. If the drafter does not know the answers, questions should be posed to legislative counsel.
