The purpose of the infographic is to narrow down ways the community can receive services through the Behavioral Health Division (BHD) and/or the Department of Health &amp; Human Services (DHHS). E-Notify is a subscription-based system which sends electronic notifications regarding any information, news, or events involving the Mental Health Board.
