I. Mayor Devine called the meeting to order at 1:15 pm.

II. Approval of the December 13, 2022 minutes

It was moved by President Besson, seconded by Mayor Kennedy, to approve the December 13, 2021 minutes. The motion carried unanimously, Mayor Neitzke abstained.



III. Update on Covid-19 Cases and Vaccinations on behalf of the Milwaukee County Public Health Collaborative COVID-19 Workgroup (Public Health Officers)

Darren Rausch and Jackie Ove provided brief COVID-19 updates. Darren advised vaccinations are still increasing. Across the County percentages are about 60%. Children at school level are about 50%. Following holidays into the present, case numbers are very high. With the volume of cases, health is prioritizing cases with congregated populations, contact, test kits, mitigation practices. Jackie advised the need for testing is very high, health is working to get antigen tests. Health is requesting assistance from the ICC to work with the State Elected Officials to obtain testing materials. Jackie noted the updated guidance from the CDC, they are working with the school districts to update their plans. County Executive Crowley thanked the Health Officials for all their hard work. Executive Crowley inquired as if there was a desire to purchase in bulk tests or masks. Mayzik inquired if Health will be drafting a request to the State in support of antigen test distribution. Ove advised they would create a draft and forward to the ICC. Health has been providing guidance to school districts, however they will not be providing guidance on staffing. Mayor Neitzke suggested drafting a letter requesting the antigen tests be shared.

Ove shared that there is a large surge at testing sites due to a nationwide shortage of home testing kits.

Public comment from Paul Mozina regarding masks and COVID medical treatment.

IV. Milwaukee County Supervisor Update – 1st and 3rd District Supervisors Sumner and Wasserman Analysis

District 1 Supervisor, Liz Sumner advised Municipalities may participate if interested in contributing in the ARPA funding task force process. The Oak Leaf sink hole has been repaired. District 3 Wasserman representing Northeast area. Supervisor Sheldon Wasserman reviewed an update on the Opioid settlement. Many municipalities will be receiving their individual settlement, including Franklin, Oak Creek, Cudahy, Milwaukee, Greenfield, Wauwatosa and West Allis. Milwaukee County will receive a settlement of over \$71 million dollars over 18 years, 20% will go to attorney fees. County Board approval will be needed for the use of this money in the Opioid abatement. Money can only be used for overdoses, training, prevention programs, etc.

VI. Diverse & Inclusive Communities Strategy Team – Jeff Roman

Jeff Roman is working with many of the leaders of the County and encouraging ICC members to become part of the work of this team. Jeff provided an update on the work completed in 2021 and the work that is aligned with their strategic plan. The work is focused on two main areas; and increase the quality of life and opportunities for people of color and, to build upon opportunities that exist for inclusiveness within the Municipalities.

Three primary goals are; identifying barriers to diversity, creating more welcoming spaces in County, actualize the influence within the communities.

President McCullough McKaig advised that their community has been working with the team to look through diversity initiatives. She also requested to reconvene the adhoc ICC team to formalize the inclusiveness work. President Montgomery thanked those working on this project. She advised that in Brown Deer paused during the Village Manager vacancy. She also advised they are collaborating with the school districts.

Jeff Roman welcomed the ICC to share in these goals. It was determined a proposed ad-hoc committee of the ICC be placed on the upcoming agenda for discussion and possible motion.

VII. Discussion and possible action – Red Light Camera Legislation – Mayor Kennedy

Mayor Devine advised this item to be held.

IX. Discussion and decision(s) regarding pending legislation which may have an impact on the ICC communities

Dennis McBride shared concerns regarding medical centers have never been taxed and have been historically exempt. When the medical center was purchased from County, they are now taxable. Mayor McBride is advising that the legislation is passed that these lands are exempt, all of the other medical care entities could also



request exemption. Attorney Alan Kesner, City Attorney from Wauwatosa provided an explanation of the definition of 501c3 exemption.

Alec Knutson advised that they are working on an alteration to the bill. Mayor Frazer inquired why MREC structured the sale in this manner. Mayor McBride requested support from the ICC in opposition of the potential bill passage in the current form. McBride made a voice recommendation for support of Wauwatosa to move forward with joint opposition to this legislation. Upon verbal request for agreement, there were no objections from the attending ICC members to pursue this point of opposition. Discussion and consent were stated that in the case an emergency meeting needs to be held if required to respond to upcoming legislative action. Discussions are ongoing with the authors of the bill, hopefully altering the bill or have the bill removed from introduction. Mayor McBride has provided the ICC members with documents related to this legislation.

Millie Colby asked the ICC members to encourage residents to use the website for employment opportunities. Employ Milwaukee are also managing the warming room sites through a paid program for the homeless.
