**III. Approval of the April 11, 2022 meeting minutes**

Mayor Pavlic moved to approve the ICC meeting minutes of April 11, 2022, second by Mayor McBride. All members present voted Aye.

**IV. Milwaukee County Economic Development, County Land Sales City, Village and Town Appointees, Emily Herrick**

To carry out a sale of non-park land in Milwaukee County the ICC must appoint be a real estate certifier from each Municipality to participate in real estate process. The appointees along with the County Executive and the County Comptroller, or their designee, are appointed every two years. The last appointment was in 2020 so there is a request that the municipalities appoint or renew a slate of representatives. The appointee must be a resident of the municipality, experienced real estate individual, and not an elected official. Please forward a name of a representative to Ms. Herrick. Ms. Herrick advised that she has received 7 of the 19 appointee information from the Municipalities. Please forward your appointee directly to Ms. Herrick.

**V. State and District Update – State Senator Julian Bradley, District 28**

Senator Bradley spoke regarding current status of the state redistricting, it is possible that further lawsuits may impede the process. However, the deadline for pulling required candidate paperwork is May 31, 2022. Senator Bradley represents Franklin, Greendale, Hales Corners, and Greenfield. Senator worked with municipalities to stop a tax assessment bill in the last session, and it affected all municipalizes. Another bill that did not move forward is the EV charging stations, ultimately this is a long-term conversation before a solution is recognized. Senator advised that crime is still a concern of all communities, as well as a nationwide trend. State Senate is currently in recess. The senator invited all to reach out to him and also thanked the ICC members for the work they do. Mayor McBride advised that the District Attorney advised that due to limited beds in the County Jail people need to go out on the street, not just in Wauwatosa. Mayor McBride stated that his District Attorney needs the support to further hiring effort to assist with cases and also to provide social services to combat the crime. President Besson shared concerns that cases are dropped and not charged by the District Attorney offices. President Besson requested that this concern be addressed. Mayor Devine asked that Senator Bradley is open to conversations regarding how local governments are funded and not being so reliant on property taxes. Mayor Johnson commented on violence and public safety stating that working

Mayor Olson recognized two County Supervisors attending the meeting, Steve Taylor and Patti Logsdon. Mayor Kennedy recognized County Supervisor Willie Johnson in attendance. Mayor Olson thanked Mayor Neitzke for lending the assistance of Darren Rausch to Franklin during the interim period of hiring a new Health Officer in Franklin. Mayor Kennedy noted that the Public Health Officers were in attendance, a one-page report was shared with the members, and also will be included in minutes.

Constance Kostelac, Assistant Professor at the Medical College of Wisconsin presented information on the Milwaukee County OD-PHAST Overdose Public Health & Safety Team. She reviewed rates of overdose deaths in Wisconsin and Milwaukee County. Cassandra shared the Milwaukee County Overdose Dashboard information. The purpose of the dashboard is share awareness of overdose activity. There is timeline, geographic, rate and quantity, race and population trends. Cassandra asked for feedback via an online survey. President Walny invited members to come see the new park equipment being installed in Bayside. Mayor Shelenske advised that the City of South Milwaukee is planning their 125<sup>th</sup> Anniversary. Mayor McBride advised that Wauwatosa will celebrate 125 years as a City on May 27. Prior to that they were a village for 130 years and a town for 180 years. They also broke ground on a UW innovation center where County Executive attended the event where partnerships were also highlighted. The City of Wauwatosa is 50% tax exempt. For the last 37 years the library has been housed in the City of Glendale. The new library in Bayside will be funded by private donations with no tax payer money being used. Mayor Walny, President Anderson, and President Frazer worked hard on fundraising. Mayor Kennedy advised Glendale's new City Administrator will be starting on May 16. A reminder that there is a MMSD Election on the ICC June agenda that will take about 45 minutes and the meeting must conclude prior to 4:00 pm on that day. Bubbler Bikes and Scooters are new to Glendale. Mayor Johnson reiterated the Summer Earn and Learn program through Employ Milwaukee. The Mayor advised that there are free gun locks available at Fire Department locations as well as United Neighborhood Centers of Milwaukee. No questions will be asked. Fox Point Village Manager reported that New Barons Brewing will be at the Fox Point pool this summer along with Pete's Pops.
