From the County Executive, requesting authorization to amend Chapters 1, 9 13, 15, 30, 32, 42, 44, 46, 56, 57 and 79 and to create Chapter 34 of the Milwaukee County General Ordinances to make ordinances consistent with provisions of Wisconsin Act 62 as it pertains to the creation of the Office of the Comptroller.

A new Office of the Comptroller was created by 2011 Wisconsin Act 62 (Act 62), which also defines the specific duties and responsibilities of the Comptroller as well as expands the duties of Corporation Counsel. After a full review of current Wisconsin Statutes, Milwaukee County General Ordinances (M.C.G.O.) and current County procedures, the recommendations described below will effectuate Act 62 in Milwaukee County.
