representation of all segments of the elderly population; at least four (4) members shall reside in the suburbs of the county; at least four (4) members shall reside in the City of Milwaukee; at least one (1) member shall be a county board supervisor and one (1) member shall represent the health community. Mr. Izard will fulfill the suburban requirement.
