WHEREAS, the 2021 Adopted Budget contains \$347,000 in Org 1972 Wage and Benefit Modification for "equity based salary adjustments"; and

WHEREAS, the Department of Human Resources recommends that the \$347,000 in funding be allocated to departments for step increases and reclassifications as of October 2021; and

WHEREAS, if approved, the 2022 Recommended Budget will include full-year funding of \$1,468,000 to cover the annual cost of the proposed salary increases; now, therefore,
