- A. DHHS is requesting the creation of 12.0 FTE Youth Correctional Officers (YCO) in paygrade 14Z1, 1.0 FTE Supervisor Juvenile Correctional Officer (JCO) in paygrade 28MC, 3.0 FTE Psychiatric Nurses (Psych RN) in paygrade 27MN, 1.0 Licensed Practical Nurse in paygrade 27, and 1.0 FTE Lead YCO in paygrade NR21.
- B. In 2024, including salary and social security, the annual cost for 1.0 FTE YCO position ranges between \$67,174 to 75,436, between \$90,236 to 102,977 for 1.0 FTE Supervisor JCO, between \$73,869 to \$92,453 for 1.0 FTE Psych RN, between \$68,987 to \$82,310 for 1.0 FTE LPN, and between \$55,105 to \$82,646 for 1.0 FTE Lead YCO. Total estimated costs in 2024 is \$294,406.

The YCOs, Supervisor JCO, LPN, and Lead YCO are being incorporated into the 2024 and 2025 budgets as part of the Secure Residential Care Center for Children & Youth (SRCCCY) which is expected to open in late 2025. The 2025 SRCCCY budget assumes the shift of current Milwaukee County Accountability Program (MCAP) costs and revenues to the SRCCCY as well as savings from the elimination of costs for the State operated Lincoln Hills and Copper Lake Schools. The State is closing these facilities and Milwaukee County youth considered non-Serious Juvenile Offenders will be transitioned to the SRCCCY. The total annualized costs for these additional positions in 2025 are anticipated to be \$1,245,892.

The cost of the three Psych RN positions is offset in 2025 by a reduction of \$176,232 in professional services contract expenditures. The vendor notified DHHS-CYFS that it will no longer provide services as of 12/31/24.

- C. The 2024 estimated fiscal impact of \$294,406 will be offset by a savings in costs for Department of Correction (DOC) charges due to lower correctional placements to Lincoln Hills and Copper Lake Schools than budgeted.
- D. This fiscal note assumes the YCO, Supervisor Juvenile Correctional Officer and the LPN positions are hired and filled by pay period 19 (September 3, 2024), and the Psych RN positions are filled by pay period 24 (November 10, 2024). The fiscal note also assumes that the YCOs and Supervisor JCO positions will be filled at the bottom of the range and the remaining positions Psych RN, and LPN positions will be filled at the middle of the range. The Lead YCO is ARPA funded and its cost is not reflected in the fiscal note as it will be tracked in a separate agency if it is approved. Actual costs will be determined depending upon placement in the range.
